


- One time fee is inclusive of Rs. 5,000/- Interest free refundable Security Deposit from Classes 1 to 10.
- With effect from A.Y. 2023.24, Day School, admissions will be allowed only in Pre-primary School. For Grade 1st to 7th, new admissions will be allowed only in Day Boarding School or Residential School and From 8th Class and onward, new admissions will be allowed only in Residential School.
- The fees shall be paid only in the form of Demand Draft, RTGS or NEFT.
- Fees Once paid shall be refunded only as per the fee refund policy laid down by the Management of the School.
- In case the fee has not been paid on or before the due date a penalty of Rs. 100/- per week shall be paid by the parent along with the fees due.
- All payment must be made in favour of " MAEER's Vishwashanti Gurukul Nivasi School".
- Absence from school without prior approval by the Principal will result in the student's name being struck off the school roll. In such a case, re-admission to the school will attract the Admission Fee again.
- The parents have to clear all the fee dues in case they wanted to seek Transfer Certificate for any reason.
- One time payment concession is applicable on Tuition Fees in case of Day Scholars, Tuition Fee and Boarding Fee in case of Day School with Boarding Facility and Tuition Fee and Residential Fee in case of Residential Students. Applicable Concessions would be governed by MIT VGS Fees and Concession Policy.
- In case of Residential Student additional sum of Rs. 10,000/- to be paid as Impress Money and needs to be replenished from time to time to maintained quarterly balance of Rs. 10,000/-
- Above given Fee Structure does not include the cost of Books, Note Books, Uniform, Excursions, Celebrations, etc.
- The Management reserves all the rights to increase the fee from time to time as per the norms.
